Personal data

AZZURRO DALMATIA d.o.o. will not collect your personal data (i.e. your name, address, telephone number or e-mail address), unless you provide them voluntarily via the contact form published on www.azzurro-dalmatia.com.

When you provide us with personal data, we may ask you if you would like to receive communication from us in the future, such as brochures, emails or other information. If you wish, you can choose not to receive such communication.

If you do not want us to collect your personal data, please do not fill in the published contact forms on www.azzurro-dalmatia.com. If you have already given us such data and would like us to delete them from our archive, please send us a request for data deletion to mk@azzurro-dalmatia.com, and we will delete them within 72 hours and notify you about the deletion.

AZZURRO DALMATIA d.o.o. shall provide protection of personal data, by collecting only the necessary, basic data on users that are necessary to fulfil our obligations; informs users how the collected data are used, regularly gives users a choice about the use of their data, including the ability to decide whether or not to have their name removed from the lists used for marketing campaigns.

All user data is kept strictly confidential and is only available to employees who need this data to do the job.

All employees of AZZURRO DALMATIA d.o.o. are responsible for respecting the principles of privacy protection.

Your data is secure. AZZURRO DALMATIA d.o.o. is keeping the data in a safe place (which includes reasonable administrative, technical and physical protection to prevent unauthorized use, access, disclosure, copying or alteration of personal data) and they may only be accessed by authorized persons of AZZURRO DALMATIA d.o.o.

In addition to providing the service or information you have requested, your personal data may also be used to track the way you use our website and our products. We may also combine the data you provided us with the data we collected separately, including data you provided to other entities (with the consent that it may be shared) as well as publicly available data. We will keep your data for a reasonable period of time or as long as we are legally required.
